

PRIVACY POLICY

This notice clarifies how MARii processes your Information from the point we collect, use, share, dispose of and the security measure that we established to ensure your Information is well protected for the purpose of the MARii e-Procurement System (“e-Proc”). The term “You” refer to the registered user of the e-Proc (“User”) or viewer of e-Proc.

The purposes for collection of the Information are for our internal record keeping, to provide services to you, to improve our products and services, to customize e-Proc according to your interests, to enable you to assess your request of services, to send you festive messages, promotional message and special offers based on your privacy preferences, for better understand your needs as Users, for security and fraud prevention purposes, for the purposes of statistical analysis of data, for profiling your preferences, for finance and marketing activities, for the purpose of our corporate governance, for the purpose of our corporate exercise, to send you event invitations based on selective events and for the purposes of printed and on-line publications (collectively, “the Purposes”). The Information may be gathered from the User registration available at our website at <https://eproc.marii.my> , Purchase form (if any), Cookies, any events organised by us [Change / add to this list as appropriate].

We collect the Information provided by you which may range from your name, company name, job title, home address, e-mail address, phone number, bank account, company profile and/or information necessary to provide you with the services offered by MARii. If you fail to supply us with such Information, we may not be able to process and/disclose your Information for any of the above purposes.

We only process your Information within Malaysia, and it will not be transferred to any place outside Malaysia unless with your consent. The Information shall be made accessible and disclosed to the eligible users of the IIS and or authority for legal/regulatory purpose (if applicable).

Please be informed that your personal data may be disclosed, disseminated and/or transferred to MARii including the holding company, subsidiaries, associated, related and affiliated companies as well as their subsidiaries, associated and affiliated companies, both local and international), whether present or future (collectively, “the Group”) or to any third party organizations or persons for the purpose of fulfilling our obligations to you in respect of the purposes and all such other purposes that are related to the purposes and also in providing integrated services, maintaining and storing records.

To this end, we are committed in ensuring the confidentiality, protection, security and accuracy of your personal data made available to us. It is your obligation to ensure that all personal data submitted to us and retained by us are accurate, not misleading, updated and complete in all aspects. For the avoidance of doubt, we and/or its employees or authorized officers or agents will not be responsible for any personal data submitted by you to us that is inaccurate, misleading, incomplete and not updated. Further, we may request your assistance to procure the consent of third parties whose personal data is made available by you to us, and you hereby agree to use your best endeavours to do so.

Among the precautionary measures taken to secure your Information are by ensuring your relevant Information is kept as required by Act 709 (if applicable), no misuse of Information by

MARii, performing contract/agreement with system vendor (if applicable) and the usage of Information shall be made in compliance with this Notice. When visiting our website, we strongly advise you to always check and confirm that the uniform resource location (url) address in your internet browser is correct. This is to ensure that you are not redirected to the wrong sites. Nevertheless, you are required to ensure the security of your password and not to disclose it to another party to reduce the risk of data breaches.

The e-Proc may contain links to other sites. If you click on a third-party link, you will be directed to that site. Note that these external sites are not operated by us. Therefore, we strongly advise you to review the Privacy Policy of these websites. We have no control over and assume no responsibility for the content, privacy policies, or practices of any third-party sites or services.

We will however retain your Information for seven (7) years or if you remain as registered user to the e-Proc, and we shall also ensure the deletion of your Information should you are no longer our registered user. If you wish to withdraw your consent to the continued use, disclosure, storing and/or processing of your personal data, please submit your written request by sending us an email at procurement@marii.my. Once request has been received and verified, your personal data will be deleted within 20 (twenty) working days. For marketing information, you may request to unsubscribe from receiving marketing information at any time by using the unsubscribe function within the electronic marketing material or you may also email us your unsubscribe request.

This website does not address anyone under the age of 13. We do not knowingly collect personally identifiable information from children under 13. In the case we discover that a child under 13 has provided us with personal information, we immediately delete this from our servers. If you are a parent or guardian and you are aware that your child has provided us with personal information, please contact us so that we will be able to do necessary actions.
